## Entry Fees\*

Strider & Cadet.....FREE  
Rookie, Vintage, Women.....\$15.per day (No discounted fees)  
Novice ~ Master classes ..... \$25. per day at the event, **\$20 per rider per day if pre---entry.**  
Insurance & Park Rental Fee (**ALL COMPETITORS**) .....\$15. per competitor per day

## Additional Discounts:

Dependent children of a competitor ride at discounted rates with the purchase of ONE full price entry fee. Registration fee for the 1<sup>st</sup> dependant child is half price --- \$12.50 pre---entry (or \$15.00 day of event). Registration for additional dependent children is \$7.50/day. Non-competitor Rookie, Vintage, = \$10.00 per day. Non-competitor Novice – Rookie = \$15.
